- ♦ Elect a President Pro Tem to preside in the absence of both the council president and vice president

♦ Appointments by Borough Council:

A. Annual Appointment

B. Expiring Terms

Zoning Hearing Board (three-year term)

The dates on which terms of current members of the zoning hearing board expire need to be ascertained, and a list prepared by the Borough Secretary. Consideration should be given to asking these members if they wish to be reappointed.

Note: See Section 903(a) of the Pennsylvania Municipalities Planning Code ("MPC"): "The terms of office of a three member board shall be three years and <u>shall be so fixed that the term of office of one member shall expire each year</u>.

Note: See Section 906(a) of the MPC: "The board shall elect from its own membership its officers, who shall serve annual terms as such and may succeed themselves."

Planning Commission (four-year term)

The dates on which terms of current members of the planning commission expire need to be ascertained, and a list prepared by the Borough Secretary. Consideration should be given to asking these members if they wish to be reappointed.

Note: See Section 202 of the MPC: "Planning Commission.--If the governing body of any municipality shall elect to create a planning commission, such commission shall have not less than three nor more than nine members.

Note: See Section 203 of the MPC: "The term of each of the members of the commission shall be for four years, or until his successor is appointed and qualified, except that the terms of the members first appointed pursuant to this act shall be so fixed that on commissions of eight members or less no more than two shall be reappointed or replaced during any future calendar year, and

on commissions of nine members no more than three shall be so reappointed or replaced."
